- •The CFA charter is a globally recognized graduate-level designation that is based on the highest ethical and professional standards.
- •The CFA charter demonstrates fluency in advanced investment management and analysis that bridges practical investment decision-making skills and theoretical knowledge.
- •The self-study program is divided into three exam levels, and the curriculum is organized into 10 general topic areas that provide a framework for making investment decisions.

2023 CFA Level I



- The Level I computer-based exam consists of **180** multiple choice questions, split between two 135-minute sessions. There is an optional break between sessions. Candidates must take both sessions in order to receive an exam result.
- First session (2 hours, 15 minutes): 90 multiple choice questions, covering the topics of ethics & professional standards, quantitative methods, economics, and financial reporting and analysis
- Second session (2 hours, 15 minutes): 90 multiple choice questions, covering the topics of corporate finance, equity, fixed income, derivatives, alternative investments and portfolio management

TIME SPENT PREPARING FOR THE EXAMS



Exam Difficulty







CFA Study Process



- 1 Look at the LOS when starting a study session; In review mode should be Green, Yellow or Red
- 2 Review the notes, watch the videos get into the material;
- 3 Do as many practice problems as possible:
 - Fool me once, shame on you, fool me twice, shame on me":
 - > Speed is a skill skill gets rewarded
 - When an answer is wrong go back to the text.
- 4 You must review the CFA Institute readings Summaries, Practice Problems, Examples & Glossary;
- 5 Move forward go back and review and then move forward again..
 - Short term memory in last few weeks.....
- 6 Manage your energy but be always working.
- 7 Have printed the LOS, the Reading Summaries, the Glossary





CFA Curriculum



The readings and end-of-reading questions are the basis for all examination questions and are selected or developed specifically to teach the knowledge, skills, and abilities reflected in the CBOK. All readings include problems and solutions to help you understand and master the topic areas.

You should use the LOS to guide and focus your study because each examination question is based on the assigned readings and one or more LOS. The readings provide context for the LOS and enable you to apply a principle or concept in a variety of scenarios. The candidate is responsible for the entirety of the required material in a study session, which includes the assigned readings as well as the end-of-reading questions and problems.





CFA Curriculum



Every question on the CFA examination is based on the content contained in the required readings and on one or more LOS. Frequently, an examination question is based on a specific example highlighted within a reading or on a specific end-of-reading question and/or problem and its solution. To make effective use of the CFA Program curriculum, please remember these key points:

1.All pages of the curriculum are required reading for the examination except for occasional sections marked as optional. You may read optional pages as background, but you will not be tested on them.

2.All questions, problems, and their solutions—found at the end of readings—are part of the curriculum and are required study material for the examination.





Prof. Ted's Tips



- 1.Be comfortable with your calculator; (Ted show BA II Plus here)
- 2. Read each question carefully;
- Sometimes: read the answers first know what you are looking for first;
- 4.Answer the easier questions first but keep track of the bubble sheet
- 5.Skip questions and go back calm your nerves by starting with your best!
- 6. Manage your time;
- 7. Eliminate obviously incorrect answers;



Prof. Ted's Tips



- 8. Answer all questions;
- 9. Least likely / Most likely write down "true" or "false" beside the answers;
- 10.Increase / Decrease do a quick real example and check using 10s, 1s, 100s;
- 11.Stay focused & avoid distractions scout the exam location, wake up the same time all exam week
- 12.Exercise & Sleep well being rested is key.
- 13.Don't waste your time on social media focus and do it!
- 14.Be competitive look left look right who's going to fail? Not me I did the extra....
- 15. Have fun it is just a test!


